**: CONDITIONS OF SALE:**

1. Subject to realization of reserve prices, all sales shall be made to the highest bidder. A person bidding on behalf of another person should produce a written authority from such other person authorizing him to act on behalf of such other person in all matters at the auction sale. One person can represent only one person. In the absence of such authority the bid, if accepted will be registered in the name of the actual bidder and he shall be responsible to The Managing Director, P.M.P.M.L Pune for any loss etc. which might occur to the P.M.P.M.L. as a result of his action without proper authority. In the event of any dispute between bidders, the dispute shall be decided by the authority supervising the sale hereafter referred to as Supervising Authority and the lot or lots in question re-auctioned at his discretion. His decision shall be final and binding on all persons offering bids at the auction.

The auctioneer who is an agent of the P.M.P.M.L to secure the most advantageous bid for the P.M.P.M.L will be entitled, in accordance with the decision of the Supervising Authority to refuse or accept the bid of any person without assigning any reason whatsoever. Auctioneer will invariably announce all the conditions governing auction before commencement of the actual sale.

**2. PAYMENT FOR ACCEPTED BIDS:-**

- a) Cash payment of not less than 25% (Twenty Five Percent) of the amount of the bid shall be made on fall of the hammer. The Auctioneers may, however, without assigning any reasons, demand as higher percentage up to full amount of the bid immediately after a lot is knocked down. In doing so he shall in all cases act in accordance with directions, if any, given by the concerned Auction Committee.
  - i) Payment for less than Rs. 5,000/- (Rupees Five Thousand Only) should be made in full by cash on the fall of the hammer.
- b) The sale would be completed on the fall of the hammer and if the bidder concerned fails to forthwith pay the initial amount as explained in (a) above required, the sale shall stand cancelled and the lots re-auctioned.
- c) Balance of the value of the bids accepted on the spot will be paid by the buyer to the P.M.P.M.L., Pune within Ten (10) working days of the acceptance of bid unless otherwise extended by The Managing Director, P.M.P.M.L. Swargate Pune and Demand Draft shall be obtained in favour of P.M.P.M.L payable at Pune. The lot or lots purchased should be removed within 30 working days from the date of auction.

If the buyer fails to make payment of the balance sale value by the stipulated date or extended date the bidder shall have to make a payment of penalty at the rate of 18% per annum (Eighteen percent) on the balance sale value for the entire period of delay.

- d) In the event of failure to complete the payment of balance sale value of any lot purchased by a bidder within the stipulated period (including extension granted if any up to a maximum of 60 days from the date of sale), the sale of such lot shall be cancelled. Initial amount paid shall be forfeited and re-sold as and when the P.M.P.M.L or his representative thinks best without any notice to the bidder. All taxes, due in respect of the commercial sale under laws in force, shall be payable by the purchaser to the P.M.P.M.L in addition to the Local Sales Tax Authority and any other Tax as applicable shall be payable by the purchaser before commencing the delivery. The delivery shall not be given unless all the payable amount including all the taxes are paid to the P.M.P.M.L
- e) The successful bidder will obtain receipt of 25% amount from Auctioneer and the receipt for balance amount will be given by the P P.M.P.M.L Pune. The successful bidder will produce all the receipts in original before taking delivery of the lot.

**3. CONDITION OF GOODS: -**

- a) The goods will be sold as and where they lie. The whole of the lot or lots shall be taken from the site of accumulation with all faults and errors in description or otherwise. Quantities, qualities, sizes, measurement, number and weights as stated in the Catalogue are approximate and no warrantee or guarantee shall be implied. Stores are sold on the assumption that bidders have inspected the lots and known what they are buying, whether they have first inspected them or not. No complaint will be entertained and no reliance must be placed on any description.
- b) In special cases when the Supervising Authority proposes to auction any particular item or items of stores by weight or number and lot on lot basis, announcement to that effect shall be made before the stores is put to auction. The bids in such cases shall be for each number or unit or weight. The price to be charged shall be calculated on the actual weight or numbers delivered. This however, does not apply to sale in lots as stated in para 2(a) above. The quantities mentioned in the sale Catalogues are only tentative and no claims will be entertained in this respect.

**4. RISK: -**

The goods shall be and remain in every respect at the risk of the buyer from the date of acceptance of his offer. The P.M.P.M.L shall not be liable/ responsible for the sale custody and/or preservation thereof from the date of acceptance till the date of final removal.



**5. DELIVERY: -**

The Managing Director P.M.P.M.L Pune will issue sale orders with copy of the Managing Director P.M.P.M.L Pune and buyer on the basis of which the buyer will make this payment of the balance amount to the P.M.P.M.L Pune either in cash or by Demand Drafts and shall obtain the receipt. After making the balance payment, the buyer shall approach the P.M.P.M.L, for release of the goods sold to him. The P.M.P.M.L shall then make necessary arrangement for giving the delivery of the goods sold. The goods sold shall be removed by the buyer from the site of accumulation within the period of 30 (THIRTY) working days from the date of acceptance of bid. Deliveries will be made only during working hours on all working days on presentation by the buyer to P.M.P.M.L Pune the copy of Sales Release Order. The buyer shall make his own arrangement for transport and he will not be entitled to claim any facilities or assistance for transport from the P.M.P.M.L

The delivery period for lots sold will be 30 working days from date of acceptance of bid. After expiry of the initial period or extended period if the material is not lifted, the extension shall be granted up to 10 days with 1% penalty/ground rent per day by the P.M.P.M.L Pune.

If the original buyer wishes to take delivery of the stores purchased through his representative, he must authorize his representative by a letter of authority, which shall be presented to the Managing Director P.M.P.M.L Pune.

The successful bidder or his authorized representative if found indulged in the malpractices while taking delivery of their lot/lots, the amount paid by them or part thereof will be forfeited by the P.M.P.M.L Pune without any notice and delivery of that lot will not be given to them. Decision taken by the Managing Director P.M.P.M.L will be binding on the concerned bidder. Further litigations in such matters will not be binding on P.M.P.M.L

**6. NON DELIVERY :-**

Where goods are sold on the basis of lots and not by numbers or units of measurement, in the event of the lot or lots being found to be deficient in quality, quantity, size, measurement, number weight as stated in the Catalogue, the purchaser shall have no claim against the P.M.P.M.L. or against the Auctioneers for refund of whole or any part of the purchaser money, or for loss of profit, interest, damage or otherwise.

Where goods are sold by weight or other units of measurement and not on the basis of lots and the buyer fails to obtain delivery of all or a portion of the goods sold, he shall not be entitled to make any claim other than for proportionate refund of the value of the undelivered quantity. He shall not be entitled to claim any damage, loss or profit, interest, or compensation on any other account.

7. Re-Sale will not be recognized and sale orders and delivery challans shall be made in the name of the actual buyer only.

**8. FAILURE TO TAKE DELIVERY AFTER PAYMENT :-**

The lots paid for must be completely removed at the buyer's expenses within the period specified. If any lot is not removed within the time specified, the P.M.P.M.L may re-auction the said lot or lots or portion thereof and the P.M.P.M.L will recover penalty at the rate of one percent per day on the original sale price of the said lot or lots or portion thereof till the date of cancellation of sale or its final removal from the scrap yard.

Without prejudice to the right to resale, the P.M.P.M.L. as its discretion will permit the buyer to remove the said lot or lots or portion thereof within an extended period(s) as specified in Clause No. 5 above (delivery clause) and on payment in advance of penalty at the rate of 1% per day default of the sale price of each lot or lots or portions thereof remaining uncleared until the date of final removal (inclusive).

9. The buyer shall be responsible for any damages that may be caused to the premises in taking or removing the lot or lots bought by him. The P.M.P.M.L may, at its option arrange to make good such damages and the buyer shall be liable to pay the same on demand.
10. In the event of the Auctioneer or the Supervising Authority of P.M.P.M.L being of opinion that bidders are forming ring/cartel and fair prices are not being realized for goods offered in auction, the Auctioneer may stop the sale with the consent of the Auction Committee.
11. The P.M.P.M.L reserves the right to withdrawing from the sale any quantity from the lot or lots advertised in the Catalogue prior to the acceptance of any bid or such lot/lots at the auction without assigning any reasons.
12. Whenever any claim for the payment of sum of money arises out of or under this auction sale against the buyer, the P.M.P.M.L shall without prejudice to any other remedy be entitled to deduct such sum of money from the proceeds of resale under this contract or from any sum then due or which at any time thereafter may become due to the buyer under this or any other contract with P.M.P.M.L. and if sufficient amount is not due to buyer to cover the full amount recoverable from him, the buyer shall pay that to P. M.C. on demand the balance remaining dues.
13. The possessing of the vehicle will not be granted to the purchaser unless a valid towing permission is obtained by the buyer from the R. T. O. 's office, P.M.P.M.L. will not handover any document related to the Scrap Vehicles to the buyer.

14. All disputes and differences arising out of or in any way touching or concerning this sale whatsoever shall be referred to the sole arbitration of the Managing Director P.M.P.M.L. Pune whose decision will be final and binding.
15. No picking, sorting, cutting or breaking up of goods material sold will be permitted. In special circumstances with a view to facilitate easy loading, the Supervising Authority or his representative may at his discretion give permission against request in writing. Such permission will be recorded in the bid sheet and delivery order. Such permission, however, will be accorded on the direct understanding that the delivery order for such lots must be obtained for the full quantity before picking, sorting, cutting or breaking. Dismantling of vehicles within P.M.P.M.L premises, however, will not be permitted.
16. Weighment will have to be arranged by the purchaser. Weighments scales approved by Weights and Measure Department to be bought by the purchaser at his cost. Loading will be done by the Purchaser's Labour.
